## TERMS AND CONDITIONS

### 1. Membership

1.1 Only individuals may be members of the Super Butcher Discount Card program. A \$AU40.00 + GST annual membership fee applies. A person who wishes to become a member can apply in the ways provided by Super Butcher from time to time, and will be bound by these Terms and Conditions, as varied from time to time. These Terms and Conditions will apply to all Super Butcher transactions, whether before or after these Terms and Conditions become binding.

1.2 Members must be a minimum of 18 years

1.3 Super Butcher may refuse any application for membership at its own discretion.

1.4 A member will be bound by these Terms and Conditions upon acceptance by Super Butcher from Internet applications.

1.5 A member must maintain an Australian postal address with Super Butcher and notify Super Butcher immediately of any change of email or postal address, or mobile phone number, or of a lost or stolen membership card. Super Butcher is not liable for any delay in replacing a membership card or for any unauthorised use of a membership card. Replacement cards will cost \$15+GST and will be shipped within 15 business days.

1.6 Membership is for 1 year from the date the card is issued. The only exception is, if a member signs up before the 1<sup>st</sup> of December 2010 then that member will receive an extra month membership and will expire on the 31<sup>st</sup> of December 2011. A renewal notice will be sent to the member within 20 business days from the expiration of the membership. The extra month will not be included in the following years renewal.

1.7 All payments of membership fees are to be through the online membership registration site at [www.superbutcher.com.au](http://www.superbutcher.com.au).

1.8 Super Butcher may terminate a membership in the Super Butcher Discount Card program without notice for any reason including, without limitation, if the member :

1.8.1 fails to comply with these Terms and Conditions;

1.8.2 supplies any misleading information or makes any misrepresentation to Super Butcher; or

1.8.3 does not use his or her membership card for a period of 12 months or dies or becomes bankrupt.

1.8.4 Termination of membership by Super Butcher is effective without notice. Super Butcher will attempt to notify the relevant member (except in the case of death) at their email or postal address in Super Butcher ' records. Termination of membership or supplementary card by a member will not take effect until the member gives written notice to Super Butcher . On receiving a notice of termination of membership from a member, the member's contact details will be noted on the Super Butcher database as closed.

1.9 Membership cards are not credit or charge cards, are not transferable, and remain the property of Super Butcher

1.10 Any tax, liability or duty arising from a member's participation in the Super Butcher Discount Card program is the responsibility of the member.

1.11 All money is in Australian dollars (AUD)

4.1 The Policy on Information Privacy issued by Super Butcher forms part of these Terms and Conditions, but shall prevail over these Terms and Conditions if they are inconsistent in any respect.

4.2 Super Butcher also reserves the right to make any changes at any time without prior notice and in their absolute discretion to the goods and services which are qualifying for membership discounts.

4.3 Information concerning members, including information contained in the application form and information as to transactions resulting in application of discounts will be held in a secure online database for Super Butcher "the Super Butcher Database".

4.4 The Super Butcher database contains some or all of the following member information:

4.4.2 name, address & telephone number(s)

4.4.3 electronic addresses

4.4.4 date of birth

4.4.5 transaction details associated with purchases from Super Butcher

4.5 Subject to the Policy on Information Privacy, information from the Super Butcher database will be made available to agents involved in administering the Super Butcher Discount Card program including a telephone service centre, agents producing cards and data processing agent as well as Super Butcher and its agents. Information from the Super Butcher database will also be made available to and used by Super Butcher, its agents for marketing (direct and all other kinds), planning, product development, research and other commercial purposes. Each member consents and agrees to the provision of the information on the application form to Super Butcher and authorises Super Butcher to seek access to the information contained in it; The Super Butcher Database will not be made available to anyone outside of Super Butcher and its agents.

4.6 Super Butcher reserves the right to suspend or terminate the Super Butcher program at any time without prior notice. Super Butcher will not be liable for the suspension or termination of the Super Butcher program on any account whatsoever.

4.7 All conditions and warranties, whether express or implied and whether arising under statute or otherwise, as to the condition, suitability, quality, fitness or safety of any goods or services supplied under the Super Butcher program are expressly excluded to the full extent permitted by law. Any liability Super Butcher may have to a member under statute in respect of such goods and services which cannot be excluded is limited, where permitted, to supplying, or paying the cost of supplying, the goods or services again, the goods.

4.8 Subject to paragraph 5.6, any liability that Super Butcher may have to a member whether for negligence, breach of contract or otherwise is, to the extent permitted by law.

4.9 A notice shall be deemed to be given by Super Butcher to a member if it is sent to the member's postal or electronic address appearing in Super Butcher database.

4.10 In these Terms and Conditions "Super Butcher " means Am No. 1 Pty Ltd (ABN 73 098 412 232) or its authorised representatives, and "Super Butcher Discount Card program" means those arrangements by which a member receives discounts and other promotions or services under these Terms and Conditions.

1.12 Membership discounts are only available to Australian Residents.

1.13 Transmission of payment for membership will be via a 3Play Networks secure portal which is secured by a current SSL certificate. No credit card details will be kept on the Super Butcher database. All credit card details will be transacted through Secure Pay Pty Ltd (ABN 92 088 101 875)

1.14 Super Butcher does not offer a refund for the membership fee for the loyalty rewards program. Normal retail and consumer refund policies will apply to goods and services provided by Super Butcher.

**2 Membership Discounts and Benefits**

2.1 Super Butcher members will be entitled to 10% discount on non-sale items for the duration of the membership

2.2 Members will also be entitled to receive special promotions or additional discounts from time to time.

**3 Claiming a Discount**

3.1 A member will need to present their issued card to be scanned. The membership discount will be automatically calculated on non-sale items and membership discounted items.

3.2 Discount will only be made available in the name of the member, or a person in the immediate family of the member.

3.3 All membership discounts are subject to such other terms, conditions and restrictions (with Super Butcher or the relevant discount provider) as are communicated or referred to by Super Butcher from time to time, including (without limitation) on the Super Butcher website or in email or SMS correspondence.

**4 General**

4.1 From time to time Super Butcher may, in its discretion, make any change it sees fit to these Terms and Conditions, the range of rewards and points required for rewards, the terms and conditions applicable to rewards and the range of participating retailers, even if the change has the effect of reducing or eliminating the number or value of, or the period for expiry of existing or future points in, the points balance in any member's account. Subject to the following, Super Butcher need not give members notice of any such change. If Super Butcher changes these Terms and Conditions, then Super Butcher will attempt to give members advance notice of the change by:

4.1.1 including the change on the Super Butcher website; and

4.1.2 Referring to the change in the course of ordinary periodic communications (if any) sent to any members, between the time Super Butcher resolves to make the change and the date when the change takes effect. The validity of the change will not be affected by any member not receiving notice through these measures.

6.3 All information and services at the Site are provided on an "as is" basis. To the fullest extent permitted by the applicable law, Super Butcher excludes all terms, conditions and representations express or implied. Any liability of Super Butcher under these terms and conditions, under any other provisions that by law cannot be excluded or that are not otherwise excluded under this clause is, where permitted by law, limited at the option of Super Butcher to the resupply of the relevant information or services. In no event will Super Butcher be liable for any consequential or indirect loss incurred by you in relation to use of the Site or rewards program.

**7 Indemnity**
